The Nursing Practice Act, Chapter 301 of the Texas Occupations Code, includes laws and rules regulating nursing education, licensure, and practice. In addition to Chapter 301 (the Nursing Practice Act), the Board of Nursing stipulates that Texas nurses are required to be familiar with Chapter 303 (Nursing Peer Review) and Chapter 304 (the Nurse Licensure Compact).

Texas is a member of the nurse license compact, and has been since 2000. Nurses may be licensed by endorsement or examination. Texas uses the NCLEX-RN and NCLEX-PN, as do all states. Texas RN candidates had a pass rate of 90.70% in 2012, very close to the national average of 90.22%.
